

Short Film Competition, 2024

Society for Conservation and Healing of Environment, invites short films for its 'Short Film Competition 2024'. The theme of this competition is "Environment". This competition aims to recognize the creative efforts towards promotion and protection of environment.

By participating in the competition, participants agree to be bound by, and are deemed to have read and understood these Terms and Conditions.

GENERAL GUIDELINES:

- 1. The Competition is only for Indian filmmakers.
- 2. There is no bar on the number of films sent by an individual for competing but each film should be sent as a separate entry.
- 3. The applicant should attach his/her identity, such as, Aadhar Card, Voter Identity Card, PAN Card, Driving License or any other valid proof of identity issued by a Government authority.
- 4. Entry Fee: There is no entry fee.
- 5. Submission of the Short Film will end on January 15, 2024 at 05:00 PM.
- 6. All entries for the Competition must be submitted by sending a downloadable link to sochngo.contest@gmail.com. Subject line of email should contain Title of short film, name and mobile number of the applicant. Entries will be accepted only when accompanied by scanned copy of completed entry form.
- 7. Entries open only for Short Film with duration of maximum 3 minutes (180 seconds), made either in Punjabi or English and completed on or after January 1, 2020.
- 8. The content of the Short Film should be suitable for Universal viewing.
- 9. Theme of the film: Subject matter must be based in Punjab concerning either an environmental concern or problem or an environmental success story about a person, group or project.
- 10. Title & Credits: Each film should depict its title and credits, including the names of the producer, writer and director.
- 11. Each entry should accompany brief theme and synopsis of the film in writing. (The film could be a documentary, non-fiction, in any technical format, including animation).
- 12. All films are required to be submitted in HD Format (MP4) downloadable link.
- 13. All selected entries for "Short Film Competition, 2022" will be the intellectual property of the SOCH
- 14. The Participant(s) represent(s) and warrant(s) that he/she will comply with all applicable Indian laws.
- 15. Judgement: The Jury looks for content, treatment, presentation, authenticity, accuracy, technical excellence, educational value and motivational elements. Jury consists of a panel of experts and professionals from diverse backgrounds such as environment, film production, academicians, media, Industry representatives, cinema and advertising world etc.
- 16. Taxes: All taxes, fees and surcharges on prize money are the sole responsibility of the winners
